

- Participation of public and private schools in the activities shall be subject to the no disruption of classes policy stipulated in DepEd Order No. 9, s. 2005 titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith, and the policy on off-campus activities stated in DepEd Order No. 66, s. 2017.
- 2. Conduct of live performances shall be subject to the IATF guidelines on face-to-face activities. Also, all activities shall be subject to the no-collection policy under Kepublic Act No. 5546 also known as An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities, which states:

Sec. 1. The sale of tickets and/or the collection of contributions in any form whatsoever. by any person for any project or purpose, whether voluntary or otherwise, from school children, students and teachers of public and private schools, colleges and universities is hereby prohibited: *Provided, However*, That this prohibition shall not cover membership fees of school children and students in the Red Cross, the Girl Scouts of the Philippines and the Boy Scouts of the Philippines: *Provided, Finally*, That this prohibition shall not cover the contributions of parents and other donors for the support of barrio high schools."


