## CONTRACT FOR THE SUPPLY AND DOOR-TO-DOOR DELIVERY OF SUPPLEMENTARY LEARNING RESOURCES (SLRs) FOR LOT 1

### KNOW ALL MEN BY THESE PRESENTS:

This Contract is entered into by and between:

Department of Education - National Capital Region, with office address at Misamis St., Bago Bantay, Quezon City herein represented by JOCELYN DR. ANDAYA, Director IV, and hereinafter referred to as the PROCURING ENTITY.

-and-

**HRRP ENTERPRISE** a private entity with office address at 8 Saint Michael St., Paradise Village, Brgy. Sangandaan, Project 8, Quezon City represented by **MA. RUTH GERARDINE R. PASCUAL**, General Manager and hereinafter referred to as the **SUPPLIER**,

collectively, the "Parties".

#### WITNESSETH:

**WHEREAS**, DepEd Central Office downloaded funds per Sub-ARO No. OSEC-NCR-23-5892 dated October 24, 2023 for the procurement of SLRs for Library Hubs and the invitation to bid for the supply and door-door delivery of SLRs was posted on November 17, 2023;

**WHEREAS**, three prospective bidders namely: Adarna House, Inc., HRRP Enterprise and Lampara Publishing House, Inc. submitted their bid proposals for Lot 1 within the deadline of submission on December 13, 2023;

**WHEREAS**, Adarna House, Inc. and HRRP Enterprise were declared failed while Lampara Publishing House submitted a bid for Lot 1 in the amount of Php14,820,000.00;

**WHEREAS**, Adarna House, Inc. and HRRP Enterprise submitted motion for reconsideration. Adarna House, Inc. was denied per BAC Resolution No. 94, s. 2023 while HRRP Enterprise was granted per BAC Resolution No. 93, s. 2023;

**WHEREAS**, the opening of bids of HRRP Enterprise for Lot 1 was conducted on December 27, 2023 and it submitted a bid in the total amount of Php5,182,440.00;

**WHEREAS**, per post-qualification evaluation, it was found out that **SUPPLIER** is compliant with requirements. Pursuant thereto, the Bids and Awards Committee (BAC), recommended to the Regional Director, as Head of the Procuring Entity, the approval of award of contract to the **SUPPLIER** per BAC Resolution No. 105, s. 2023 dated December 28, 2023.

**NOW, THEREFORE**, in consideration of the foregoing premises and of the mutual covenants and undertaking set forth, the parties have agreed, as follows:

ARTICLE 1. OBLIGATION OF THE SUPPLIER. That, the SUPPLIER shall supply and door-to-door deliver the SLRs to the fifteen (15) Library Hubs of DepEd NCR within **forty-five (45) days** period from the receipt of the Notice to Proceed (NTP).

ARTICLE 2 - CONTRACT PRICE. The contract price is **Five Million One Hundred Eighty-Two Thousand Four Hundred Forty Pesos** (**Php5,182,440.00**). The **Procuring Entity** shall pay the full payment of the contract price after complete delivery of SLRs to recipient Library Hubs and upon submission of billing statement and other necessary documents, subject to the usual accounting and auditing rules and regulations;

ARTICLE 3 – LIQUIDATED DAMAGES. In case of delay in the performance of its obligation, the SUPPLIER shall be liable to pay the PROCURING ENTITY liquidated damages at the applicable rate of one tenth (1/10) of one (1) percent of the cost of the unperformed portion for every day of delay until actual complete delivery or performance pursuant to GPPB resolution No. 02-2020. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of this Contract, the PROCURING ENTITY shall rescind this Contract, without prejudice to other courses of action and remedies open to it.

5.1. Any litigation arising from this Contract shall be filed in the courts of Quezon City.
