



 - 2.2. National Screening and Accreditation of Athletes for Measurable Sports who are undergoing training abroad and replacements is scheduled on **July 8, 2024,** in Cebu City.
 - 2.3. Deadline of submission of FINAL Masterlist to NSAC is June 25, 2024
 - 2.4. Distribution of ID stickers (screened athletes) is July 8, 2024
 - 2.5. Submission of Final Masterlist and Photo Gallery to the Palaro Board is July 9, 2024.
