

Suicide remains one of the most pressing public health issues globally, with lasting harmful effects on individuals, families, and communities. In 2019, suicide was the fourth leading cause of death among individuals aged 15–29 years worldwide. In the Philippines, despite being underreported, the suicide rate is estimated at 3.2 per 100,000 population, with higher rates among males than females (Department of Health, 2020).

The agenda 6 of the Department of Health 8-point Action Agenda is focused on improving and protecting psychosocial and mental well-being to reduce the burden of mental health disorders and the incidence of suicide. This is to be achieved by developing personal skills towards health literacy and reorienting health services and communities towards health promotion.

To actualize these objectives, the Department of Health – Metro Manila Center for Health Development (DOH-MMCHD) will conduct **Training on Suicide Prevention and Intervention Skills** on October 1 to 3, 2024 at Ciudad Christhia 9 waves Resort Inc., San Mateo Rizal. In line with this, we would like to invite two (2) participants per Schools Division Office (SDO) and three (3) personnel from the DepEd Regional Office to attend the said training.
