

DISTRIBUTION OF DONATED WHEELCHAIRS TO RECIPIENT SCHOOLS DIVISION OFFICES

- 1. Align with DepEd Order No. 72, s. 2009, titled "Inclusive Education as Strategy for Increasing Participation Rate of Children", DepEd-National Capital Region (NCR) tapped potential partners and stakeholders to provide supports and better access to learners with mobility challenges, thereby fostering inclusivity in basic education in all public schools in the Region. This will also create supportive and welcoming environment so that learners with disabilities can fully participate in all educational activities.
- 2. The Maginoo Shrine Club represented by **Mr. Jimmy Lao** is actively involved in helping schools with crippled learners.
