### INTERVENTION MEASURES IN THE COMPLETION, COMPLIANCE, AND UTILIZATION OF THE FY 2025 WORK AND FINANCIAL PLAN IN PMIS

- 1. In reference to **DepEd Order No. 11, s. 2021**, **Guidelines on the Operationalization of the Program Management Information System (PMIS)**, the DepEd-NCR supports the utilization of PMIS in terms of Planning and Budget Strategy as integral part of:
  - a, support the effective and efficient management of plans and programs;
  - b, increase transparency of plans and programs at all levels of governance;
