This is in reference to the conduct of the National Orientation on Proper Handling of Disclosure and Data Privacy by the Learner Rights and Protection Division (LRPD).

Pursuant to the 1987 Constitution, the State shall defend the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to their development. Pursuant to this Constitutional mandate, the Department established the LRPD to lead the planning, implementation, coordination, monitoring, and evaluation of programs related to learner rights and protection.

One relevant program on learner protection is the operation of the Learners TeleSafe Contact Center Helpline (LTCCH)— the official unit of the Department in responding to reports of abuse, violence, exploitation, neglect, and other conditions prejudicial to the development of learners. Based on the cases received by the LTCCH, issues on handling disclosures and the protection of the right to data privacy of learners have emerged as challenges in responding to protection concerns.

It shall also be recognized that DepEd personnel, especially the members of the Child Protection Committee, are bound to follow certain laws, rules, and regulations on handling disclosures and data privacy. To avoid violations of these laws, rules, and regulations, it is imperative to orient DepEd personnel on the procedures for maintaining the integrity of disclosures and compliance with the Data Privacy Act. Hence, the LRPD proposes to conduct the "National Orientation on the Proper Handling of Disclosure and Data Privacy."

The National Orientation on Proper Handling of Disclosure and Data Privacy shall have the following objectives:

- a. Identify and understand the roles of child protection committee members in handling disclosures and respecting data privacy rights of learners;
- b. Recognize the importance of confidentiality and sensitivity of data; and
- c. Understand the principles, guidelines, discipline in handling disclosures.

The Orientation will be conducted from April 14-16, 2025 at Ecotech Center, Lahug, Cebu City. Participants are expected to check in at the venue on April 14, 2025, Monday, at 2:00 PM, and should check out on April 16, 2025, Wednesday, at 12:00 NN.

The desired participants shall charge their travel expenses to the local funds or the appropriate downloaded funds of the LRPD to the Regional Offices, subject to government accounting and auditing rules and regulations.
