

While reference "c" provides direction to commence the regional validation for GK Seal for LDRRMCO Category and Special Awards Categories.

II. PURPOSE

This Memorandum is issued to supplement the NDRRMC MC No. 3, s. 2025 and prescribe the timeline of activities for the effective implementation of the Gawad KALASAG Program in NCR. Additionally, it seeks to reconstitute the Regional Validation Committee and the Regional Selection Committee to enhance the evaluation process, uphold transparency, and ensure the recognition of outstanding efforts in disaster risk reduction and management in the region. Lastly, it aims to reiterate the commencement and call for entries for GK CY2025 in NCR.

III. REGIONAL GAWAD KALASAG ACTIVITIES

The OCD NCR, as the Regional GK Secretariat, will take the lead in facilitating the following activities:
