

This has reference to the *Complaint* received by the Learners TeleSafe Contact Center Helpline, Learner Rights and Protection Office, Department of Education relative to alleged psychological violence committed by the school head at Ernesto Rondon High School, Quezon City.

The complaint alleged that the school of the said school, Dr. Arliana Arboleda, shouted, humiliated, and threatened those who are in school.

DepEd Order No. 40, s. 2012 refers to "psychological violence" as "acts or omissions causing or likely to cause mental or emotional suffering of the child, such as but not limited to intimidation, harassment, stalking, damage to property, public ridicule or humiliation."

Further, DepEd Order No. 49, s. 2006¹, provides that the Schools Division Office has jurisdiction over disciplinary cases against the learners and the school of this Department.

In view of the forgoing, this Office through the DepEd Learner Rights and Protection Office (LRPO) requests the submission of an incident report and intervention plan to assist the learners concerned within five business days upon receipt hereof². Kindly
