PRIVATE SCHOOLS' TRAINING ON THE MATATAG CURRICULUM

- In reference to the Memorandum dated December 20, 2023, the Office of the Officer-in-Charge, Undersecretary for Human Resource and Organizational Development, the Regional Office through the Human Resource Development Division (HRDD NEAP-R), Quality Assurance Division (QAD), and Curriculum and Learning Management Division (CLMD) announces the conduct of the Private School's Training on the MATATAG Curriculum for Kindergarten, Grade 1, Grade 4 and Grade 7 (K147) Teachers and School Leaders in preparation for the commencement of the initial phase of the MATATAG Curriculum implementation.
- The series of trainings on the MATATAG curriculum focuses on providing professional development support for private school teachers and school leaders, ensuring that they have an in-depth understanding of the general shape of the MATATAG Curriculum. Specifically, it aims to equip private school teachers and leaders with the necessary knowledge, skills, and competencies to implement the new curriculum effectively in the coming school year.
- Anent to this, private schools and/or private schools associations shall organize their 5-day training on the MATATAG Curriculum in proper coordination with the SGOD and CID Chiefs and SEPS of HRD and M&E.
- The pool of trainers for the training on the MATATAG Curriculum **shall be composed of the trained Regional and/or Division trainers.**
- This professional development program shall adhere to the NEAP standards, DM. 44, s.2023 *Interim Guidelines for the Quality Assurance and Monitoring and Evaluation of NEAP Core Programs.*

6. Training designs, matrices, monitoring and evaluation tools, terms of reference, and forms will be provided by the respective Schools Division Office for the private schools conducting the training.
7. The MATATAG Curriculum Training Resource Packages will be made accessible only to SGOD and CID Chiefs to be used solely during the conduct of the training. **Sharing the training resource package with unauthorized individuals or entities without proper authorization is strictly prohibited. Any potential problems arising from such unauthorized sharing will be the sole responsibility of the Chiefs and DPMT.**
8. The Regional and Division Monitoring Team will be responsible for overseeing the training and providing technical support as needed.
9. The Program Management Team (PMT) of the training shall prepare and submit the completion report to the SGOD - Schools Division Office, 10 working days after the conduct of the program.
