The Alliance Française de Manille and the Alliance Française de Cebu will simultaneously administer the **Diplôme d'Études en Langue Française (DELF) A1 Examination** on **July 28, 2025, 9:00 a.m. to 5:00 p.m.** at the Alliance Française in Manila, Nicanor Garcia Street, Bel-Air II, Makati City, and Alliance Française in Cebu, Gorordo Avenue, Cebu City.

This language proficiency examination certifies that candidates have acquired very basic French language skills and corresponds to the first level (A1) on the six-level scale of competence laid down in the Common European Framework of Reference for Languages (CEFR).

In this regard, the Department of Education (DepEd), through the Bureau of Curriculum Development-Special Curricular Programs Division, invites **70 Grade 10 learners under the Special Program in Foreign Language (SPFL)-French (35 learners each from NCR and Region VII)** to take the DELF A1 examination.

The examination fees will be covered by the Embassy of France in the Philippines and Micronesia, DepEd's partner in the implementation of SPFL-French. The transportation expenses, meals, accommodation (where necessary), and other incidental expenses shall be chargeable against the School Maintenance and Other

Operating Expenses (MOOE), Special Education Fund, and/or other local funds subject to usual accounting and auditing procedures.

To ensure the safety of learners, the school shall provide transportation services for all learners taking the examination. Alternatively, SPFL-French teachers may accompany the learners. In such cases, the participation of teachers shall adhere to the provisions of DepEd Order No. 9, s. 2005 titled *Instituting Measures to Increase Engaged Time-On-Tasks and Ensuring Compliance Therewith* to ensure that learning shall not be disrupted.

To facilitate the registration of learners by the Embassy and the Alliance Française, the Regional Education Program Supervisors in charge of SPFL are required to pre-register the learners selected to take the examination through this link <https://tinyurl.com/DELFA1Pre-registration> on or before **June 16, 2025**. Additionally, parents of learners shall accomplish the attached Parent Consent form and submit through email at bcd.scpd.spfl@deped.gov.ph on or before the abovementioned deadline.
